To Members of Market Street Advisory Committee:

This letter is in response to the meeting of April 27, 2018 for the proposal of a new Luxury Theater and Parking Garage at Market Street Lynnfield.

We, the residents living at LIFE's Colonial Village, are very concerned with the location of the new proposed parking garage. There was a discussion of two possible parking garage sites. The sites were referred to as alternative 1 and alternative 2. The residents of Colonial Village are strongly opposed to the garage site proposal for alternative 1. Alternative 1 site would be adjacent to California Pizza Kitchen and across the street from LIFE's Colonial Village. Alternative 2 site would be behind Wahlburgers restaurant and adjacent to the proposed new theater.

According to discussions at the meeting, one of the the main reasons for building the garage site at alternative 1 was that it was going to be less expensive to build it there. While this may be true, building it there would also adversely affect the quality of life and the quiet enjoyment of the residents in LIFE's Colonial Village.

We are not opposed to a new parking garage, but we are vehemently opposed to building the garage at the alternative 1 location. The alternative 2 location will not have any negative effects on the abutters and residents of Colonial Village. We strongly urge the MSAB to reject the alternative 1 site proposal and protect the interest of the residents and abutters at LIFE's Colonial Village.

Listed below are some of our concerns.

## Noise

- Car alarms going off and disturbing the quiet enjoyment of residents.
- Noise from people leaving restaurants later in the evening.
- Noise from remote control locking and unlocking of cars as people come and go.
- The noise at night travels more and is amplified in the echo chamber of the garage.

## Safety

- More traffic and cars entering next to Colonial Village's Heather Drive entrance, which is already a very dangerous curve.
- The increased traffic in this area with the backup of holiday traffic will affect the residents getting in and out of Heather Drive.

## Other

 The garage would be too close to the street and high above the closest town houses of Colonial Village.

- The alternative 1 garage site would take away from the pleasure, convenience and quiet enjoyment of living at Colonial Village.
- The footprint of the alternative 1 garage location next to Colonial Village looks to be considerably larger and much closer to the property line than the footprint of the alternative 2 location next to the theater and behind Wahlburgers restaurant.

For the reasons listed above we feel the obvious choice should be the alternative 2 location behind Wahlburgers restaurant and adjacent to the new theater. This alternative 2 location makes the theater easier to access and it would not have any adverse effects on the residents of Colonial Village.
