Town Administrator Dolan provided an over view of a potential process for moving into the next phase of design and permitting by providing some Town funding for engineering costs. The process depends on the DOT scheduling a public hearing on the 25% design by late February. A date of February 28 was mentioned as a briefing to the Selectmen. The Pace of the posting will depend on the timing of the DOT hearing and other future briefings. The Committee approved this approach unanimously. Joel, Marian, Marc and Rob will review and finalize the materials for the media postings and these will become revised FAQs if needed. Next step is to send the first summary to the paper,

Marc and Randy will work on a strategy to incorporate these new materials in a presentation.
