**Attention Dog Owners:** All Dog Licenses expire on December 31<sup>st</sup> every year. You can purchase your dog tag(s) at the Town Clerk's office, through the mail or on-line. If you plan to purchase your dog tag at the Clerk's office or through the mail, please complete the License Application below and return with:

- Payment of \$10.00 per neutered/spayed dog and \$15.00 per intact dog - payable to the Town of Lynnfield. *Residents age 70 and over the fee is waived upon proof of age – not applicable for kennel owners.*
- Copy of current Rabies Certificate – this is required annually.
- If dog tag(s) are being returned by mail, please include a self-addressed stamped (.47 cents) envelope.

**On-Line Registration and Payment.** Go to [www.town.lynnfield.ma.us](http://www.town.lynnfield.ma.us). Click "Departments" from the main page, and then click on "Town Clerk". On the left hand side of the Town Clerk's page, click on "Dog Licensing and Information". From there, follow the instructions for on line registration. Once notification has been received the rabies certificate has been uploaded and payment has been made, tags will be mailed to you. If you have a QR reader app, scan here to go directly to the website for online registration



MGL Chapter 140, Section 137 requires that all dogs six months of age or older must be licensed and evidence of a current rabies vaccination must be provided. *(The signs of rabies vary in animals; the behavior of an animal is NOT a reliable indicator of whether or not it has rabies. Some of the more common signs include: unexplained aggression, impaired locomotion, varying degrees of paralysis, hyper salivation and extreme depression)*

**Lynnfield's By-Law Section 17A** requires all dogs be licensed on January 1st of each license period. The license period is from January 1<sup>st</sup> to the following December 31<sup>st</sup>.
